

I-TOLD DANIEL I THOUGHT HIS LIP MIGHT BE BLEEDING/CUT. DANIEL TOOK A TISSUE AND WIPED LIPSTICK OFF HIS LIPS AND THREW THE TISSUE INTO THE KITCHEN.
